

Arya & Others versus Government of NCT of Delhi &Ors.

The concerned Head of Department should ensure that no disciplinary proceedings are pending at their department level, also they may ensure that no criminal proceedings are pending or any penalty is in operation against the above-mentioned officer promoted on regular basis before implementing the promotion orders.
