ORDER

On the recommendations of the UPSC, vide their communication No. F.No.1/31(9)/2025-PD-2 dated 14.07.2025, Hon'ble Lt. Governor, Delhi is pleased to appoint Shri Rohtash Kumar Sharma (Seniority No. 456), presently working as Deputy Controller of Accounts, Delhi Teachers University in diverted capacity from Directorate of Audit with additional charge of Joint Secretary(HRD), Finance, to the post of Deputy Controller of Accounts(Group "A" Gazetted in Level 11: Rs. 67700-208700 of Pay Matrix) on promotion on notional basis with effect from 19.05.2021, below Shri Rakesh Kumar(Seniority No. 431), against the vacancy reserved for PwBD (Sub-category 'C'), in terms of DoPT OM No. 36012/1/2020-Estt(Res.-II), dated 17.05.2022 and OM No. 36012/1/2020-Estt(Res.-II) dated 28.12.2023. The financial benefit of promotion will be effective to the officer with effect from the date he had actually assumed the charge of promoted post of Deputy Controller of Accounts.

2. Upon promotion, the above-mentioned officer will continue to work in the same Department in which he is presently posted, till further orders.

3. The officer shall be eligible to exercise option, if any, under the provisions of FR-22, CCS (Revised Pay) Rules and GoI's orders there under. However, option, if any, shall be exercised within one month from the date of issue of this order.

4. The aforesaid promotion is subject to outcome of further orders that may be passed by the Hon'ble Supreme Court in the case of Jarnail Singh & Ors. (Civil Appeal No. 629 of 2022) arising out of SLP (C) No. 30621 of 2011, as conveyed by the DoPT vide O.M. No. 36012/16/2019-Estt(Res.) dated 12.04.2022 duly endorsed by Services Department vide letter No. F.19(17)/2018/S.IV/631-638 dated 05.05.2022 and outcome of Contempt Petition No. 536/2015 in WP(C) No. 2062/2008 in the matter of B.R. Arya & Others versus Government of NCT of Delhi & Ors.
