2. Upon promotion, all the above-mentioned officers will continue to work in the same Department in which they are presently posted, till further orders.

All the above-mentioned officers will be on probation for a period of two years or upto the date of retirement, whichever is earlier and shall be eligible for exercising option, if any, under the provisions of FR-22, CCS (Revised Pay) Rules and GoI's orders there under. However, option, if any, shall be exercised within one month from the date of issue of this order.
