ORDER



The promotion to the post of Controller of Accounts of all the above-mentioned officers are subject to outcome of further orders that may be passed by the Hon'ble Supreme Court in the case of Jarnail Singh & Ors. (Civil Appeal No. 629 of 2022) arising out of SLP (C) No. 30621 of 2011, as conveyed by the DoPT vide O.M. No. 36012/16/2019-Estt(Res.) dated 12.04.2022 duly endorsed by Services Department vide letter No. F.19(17)/2018/S.IV/631-638 dated 05.05.2022 and outcome of Contempt Petition No. 536/2015 in WP(C) No. 2062/2008 in the matter of B.R. Arya & Others versus Government of NCT of Delhi & Ors.

4. The concerned Head of Department should ensure that no disciplinary proceedings are pending at their department level, also no criminal proceedings are pending or any penalty is in operation against any of the above-mentioned promoted officers before implementing the promotion orders. If any officer, out of the above, is not clear from vigilance angle at the departmental level, as on date, the same should be brought to the notice of this Department immediately.


