Considering the fact that the officer is going to retire on superannuation on 31.05.2025, the Competent Authority is pleased to post Shri Ramesh Chand Lakhchaura, Controller of Accounts, in Directorate of Audit on notional basis, with effect from 15.05.2025, for pay purpose only, against a vacant post. However, the officer will continue to work in Social Welfare Department, till further orders.
- 5. The concerned Head of Department should ensure that no disciplinary proceeding is pending at their department level, also no criminal proceeding is pending or any penalty is in operation against the above-mentioned promoted officer before implementing the promotion orders.
