

No. 36012/16/2019-Estt(Res.) dated 12.04.2022 duly endorsed by Services Department vide letter No. F.19(17)/2018/S.IV/631-638 dated 05.05.2022 and outcome of Contempt Petition No. 536/2015 in WP(C) No. 2062/2008 in the matter of B.R. Arya & Others versus Government of NCT of Delhi & Ors.

4. The concerned Head of Departments should ensure that no disciplinary proceedings are pending at their department level, also they may ensure that no criminal proceedings are pending or any penalty is in operation against any of the above-mentioned promoted officers before implementing the promotion orders. If any officer, out of the above, is not clear from vigilance angle at the departmental level, as on date, the same should be brought to the notice of this Department immediately.






