**ORDER**

On the recommendation of the Departmental Promotion Committee, the Chief Secretary, Government of NCT of Delhi is pleased to order promotion of Shri Rakesh Kumar, Assistant Accounts Officer (Seniority Number 592) to the post of Accounts Officer (Group 'B' Gazetted) on regular basis in Level-09 of Pay matrix, with effect from 19.09.2016 i.e. the date of promotion of his immediate junior namely Ms. Urmila Kapoor (Seniority Number 593).

2. The Competent Authority is further pleased to order transfer of Shri Rakesh Kumar, Accounts Officer from Directorate of Gurudwara Election and post him in the Office of the Deputy Commissioner (Central) with immediate effect, against a vacant post.

3. Hon'ble Lt. Governor, Delhi is further pleased to create a supernumerary post of Accounts Officer (Group B Gazetted) in Level 9 of Pay Matrix with effect from 19.09.2016 to 28.02.2023 in Directorate of Audit, Government of NCT of Delhi to accommodate Shri Rakesh Kumar, Accounts Officer. However, the post shall cease to exist immediately after the salary for the specified period is drawn in favour of Shri Rakesh Kumar on the said post.

4. Consequent upon promotion as Accounts Officer, Shri Rakesh Kumar, Accounts Officer is hereby notionally posted in Directorate of Audit for pay purpose with effect from 19.09.2016 to 28.02.2023 against the supernumerary post and shall draw with effect from 01.03.2023 onwards against regular vacant post, till such time, the officer joins his duty in office of the DC (Central).

5. Further, the penalty imposed upon Shri Rakesh Kumar by the Disciplinary Authority vide order No. F.7(26)/2015/DOV/4894/903 dated 08.04.2019, is modified and effected with reference to the promoted post of the officer in terms of DoPT OM No. 22011/2/2002-Estt(A) dated 24.02.2003.

6. The above officer will be on probation for a period of two years and shall be eligible to exercise option, if any, under the provisions of FR-22, CCS (Revised Pay) Rules and GoI's orders there under. However, option, if any, shall be exercised within one month from the date of issue of this order.

7. The Head of Department should ensure that no disciplinary proceedings are pending against him at department level, also no criminal proceedings are pending or any penalty is in operation against him, before relieving him to take up new assignment on promotion. If the officer, is not clear from vigilance angle at departmental level, as on date, the same should be brought to the notice of this Department immediately.

8. The aforesaid appointment is subject to outcome of further orders that may be passed by the Hon'ble Supreme Court in the case of Jarnail Singh & Ors. (Civil Appeal No. 629 of 2022) arising out of SLP (C) No. 30621 of 2011, as conveyed by the DoPT vide O.M. No. 36012/16/2019-Estt(Res.) dated 12.04.2022 duly endorsed by Services Department vide letter No. F.19(17)/2018/S.IV/631-638 dated 05.05.2022 and outcome of Contempt Petition No. 536/2015 in WP(C) No. 2062/2008 in the matter of B.R. Arya & Others versus Government of NCT of Delhi & Ors.
