
2. The above-mentioned officers will be on probation for a period of two years and shall be eligible for exercising option, if any, under the provisions of FR-22, CCS (Revised Pay) Rules and GoI's orders there under. However, option, if any, shall be exercised within one month from the date of issue of this order.

3. Promotion of all the above-mentioned officers, to the post of Accounts Officer, is subject to outcome of further orders that may be passed by the Hon'ble Supreme Court in the case of Jarnail Singh & Ors. (Civil Appeal No. 629 of 2022) arising out of SLP (C) No. 30621 of 2011, as conveyed by the DoPT vide O.M. No. 36012/16/2019-Estt(Res.) dated 12.04.2022 duly endorsed by Services Department vide letter No. F.19(17)/2018/S.IV/631-638 dated 05.05.2022 and outcome of Contempt Petition No. 536/2015 in WP(C) No. 2062/2008 in the matter of B.R. Arya & Others versus Government of NCT of Delhi & Ors.

4. The concerned Head of Departments should ensure that no disciplinary proceedings are pending at their department level, also no criminal proceedings are pending or any penalty is in operation against any of the above mentioned newly promoted officers, before relieving them to take up their new assignment on promotion. If any officer, out of the above, is not clear from vigilance angle at their departmental level, as on date, the same should be brought to the notice of this Department immediately.


