- 2. Considering the mapping of expenditure with the resources of Government of NCT of Delhi and for better cash management, the expenditure during the month of April, 2025 is capped at 5% of the total budget allocation in BE 2025-26 under the respective budget heads.

Expenditures to be incurred on account of salaries (object head 01) and allowances (object head 07) [excluding arrears] and wages (object head 02) will be exempted under provision of above capping of 5% for the month of April, 2025. Further, expenditure relating to salaries of outsourced staff, security and sanitation, electricity and water supply, telephone, postages charges, POL and maintenance of staff car is also exempted under this capping.
- 4. Administrative Secretaries/Head of the Department of the concerned department while issuing the expenditure sanction may make sure that during the month of April, 2025; the expenditure should not exceed 5% of total allocated budget under the respective heads for the financial year 2025-26.
