ORDER

On the recommendations of the Departmental Promotion Committee, Chief Secretary, Delhi is pleased to appoint on promotion Shri Pramod Kumar Singhal, Senior Accounts Officer, (Seniority Number 712 of AAO), presently working in Directorate of Audit, to the post of Accounts Officer (Group "B" Gazetted in Level-09 of Pay matrix of Rs. 53100-167800) with effect from 01.02.2017 on notional basis below Shri Ajay Kumar Chandna, Seniority Number 658 of AAO, against the vacancy reserved under PwBD category C (Ortho) in terms of DoPT OM No. 36012/1/2020-Estt(Res.-II), dated 17.05.2022 and OM No. 36012/1/2020-Estt(Res.-II) dated 28.12.2023. The actual financial benefit of promotion will be effective to the officer with effect from the date he had actually assumed the charge of the promoted post of Accounts Officer.

Further, on the recommendations of the Departmental Promotion Committee, Chief Secretary, Delhi is pleased to grant promotional grade of Senior Accounts Officer (Group "B" Gazetted in Level 10 of Pay Matrix: Rs.56100-177500) to Shri Pramod Kumar Singhal with effect from 01.02.2019 on notional basis. 3. Upon promotion, the above-mentioned officer will continue to work in the same Department in which he is presently posted, till further orders.

4. The officer shall be eligible to exercise option, if any, under the provisions of FR-22, CCS (Revised Pay) Rules and GoI's orders there under. However, option, if any, shall be exercised within one month from the date of issue of this order.

5. The aforesaid promotion is subject to outcome of further orders that may be passed by the Hon'ble Supreme Court in the case of Jarnail Singh & Ors. (Civil Appeal No. 629 of 2022) arising out of SLP (C) No. 30621 of 2011, as conveyed by the DoPT vide O.M. No. 36012/16/2019-Estt(Res.) dated 12.04.2022 duly endorsed by Services Department vide letter No. F.19(17)/2018/S.IV/631-638 dated 05.05.2022 and outcome of Contempt Petition No. 536/2015 in WP(C) No. 2062/2008 in the matter of B.R. Arya & Others versus Government of NCT of Delhi & Ors.
