Sub: Final Seniority List of Accounts Officers of GNCTD Accounts Services (Grade-I).

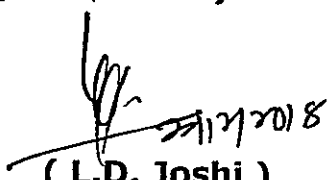
