03. Pr. Secretary (Law) apprised the Expenditure Finance Committee of the agenda items and presented their proposals before the Committee.

Agenda item No. 1.

Construction of District Court Complex at Sector-26, Rohini, Delhi at an estimated cost of Rs. 663.19 crores. (Modified Preliminary Estimates amounting to Rs. 714.98 crore submitted during the meeting)

1. The proposal of the Law Department, Govt of NCT of Delhi was for work of construction of District Court Complex at Sector-26 Rohini, Delhi at an estimated cost of Rs. 663.19 crores including 1% contingencies, 1% Quality Assurance and EPF and ESI charges @ 4.25% of building cost on the basis of DPAR 2012 and supplement for specialized E&M Works 2014 enhanced by cost index @ 37.65% and reduced @9%, as approved by the Hon'ble Special Committee (Infrastructure) of Hon'ble High Court of Delhi in the meeting held on 24.02.2020.
2. The Department has submitted that there is requirement of construction of additional courtroom in consonance with new recruitment of Judicial Officers to fill up the vacancies against the sanctioned strength of judicial officers in GNCTD. Accordingly, an affidavit was filed in Hon'ble Supreme Court of India to construct new courtrooms at plot allotted by DDA in Sector-26, Rohini, Delhi.
3. It has further been stated that the M/s. TCS Architect Pvt. Ltd the consultant architect submitted the architectural plans to Building Maintenance and Construction Committee (BMCC) of Hon'ble High Court on 29.05.2019. The Hon'ble Committee made certain observations which were incorporated in the architectural plans by the consultant and resubmitted the plans on 14.08.2019. A presentation was made by the consultant on 24.02.2020 to the Committee. The Hon'ble Special Committee of Delhi High Court approved the Architectural Plans.
4. During the course of meeting, Pr. Secretary (PWD) submitted a modified Preliminary Estimate for the work of Construction of District Court Complex at Sector-26, Rohini, Delhi to Rs.714,98,43,000/- i.e 1% contingencies, 1% Quality Assurance, 3% Anticipated Cost, 1% Art work and EPF and ESI charges @ 3.94%, stating that earlier Preliminary States were prepared on the basis of DPAR 2012 whereas the modified Preliminary Estimates is based on latest DSR/DPAR, for consideration of the Competent Authority for accord of Administrative Approval and Expenditure Sanction. EFC considered and accepted the modified Preliminary Estimates amounting to Rs.714,98,43,000/-.

5. The Engineer-in-Chief informed that stipulated period of completion of the project works is 24 months after receipt of A/A & E/S (including 4 months for detailed planning, local body approvals, preparation of NIT, Call of Tender, and 20 months for construction after award of work).

6. Pr. Secretary (Law), GNCTD invited the attention of the EFC towards "Minutes of Meeting of the Committee to take up the matter with the Government for providing the infrastructure for the District judiciary held on 25.03.2021 in the Chamber of Hon'ble Mr. Justice Siddharth Mridul". The relevant extract of the said minutes is reproduced hereunder:-

".....Since the projects have got delayed considerably, the Committee expects that all said projects are completed on top priority basis."

The Committee also directs PWD to inevitably ensure provision of various facilities as per the directions of Hon'ble Supreme Court of India passed in its order dated 02.08.2018 in I.A. No. 279 of 2010 in Writ Petition (Civil) No. 1022/1989 titled "All India Judges Association & Ors Vs Union of India & Ors" in all the aforesaid modified plans approved by the Committee".

7. Hon'ble Chair observed that in some cases of PWD, the local statutory clearances are not obtained in time, resulting in retender, which further end up with cost and time overrun. In order to obviate the cost and time overrun, Hon'ble Chair directed that PWD shall ensure that the local statutory clearances be obtained before opening of the tender.

8. The Hon'ble Chair also directed that the Plan/design duly approved by the BMCC shall scrupulously be followed without any deviation.

9. The Hon'ble Chair further reiterated that there should not be any deviation from timelines committed to the Hon'ble High Court as per the status report filed in the Hon'ble Supreme Court.

The Department has submitted that there is requirement of construction of additional courtroom in consonance with new recruitment of Judicial Officers to fill up the vacancies against the sanctioned strength of judicial officers in GNCTD. Accordingly, an affidavit was filed in Hon'ble Supreme Court of India to construct new courtrooms at plot allotted by DDA in Karkardooma.

3. M/s. TCS Architect Pvt. Ltd the consultant architect has submitted the architectural plans to 'Building Maintenance and Construction Committee' (BMCC) on 29.05.2019.
