Subject: Brief Description of SNA/CNA Reports

PFMS has developed various reports for SNA and CNA modules. These reports are available to different users as per the access rights. Two new reports SNA 12 and CNA 05 have been made live. Currently, 11 SNA reports and 5 CNA reports are available to the users. Brief details on these reports is mentioned below for better understanding:

A) SNA Reports

- SNA01 Comprehensive report for Releases and Expenditure The
 report can be generated either Controller wise or State wise and is available
 for SNA marked CSS schemes. Report shows the releases made by GOI to
 States in a particular scheme, funds received by State Nodal Agency from
 Treasury, Expenditure and Advance booked in PFMS against the SNA
 Account and with actual bank balance.
- SNA02 Agency Statement on Allocation of Fund and Expenditure

 This report shows the agency wise limit allocation, Expenditure and advance. This report is based on the limit allocation data. So, it will show only those agencies which have been allocated limits by their parent agency.
- 3. SNA03 SNA Agency Mapping Status Report shows the total number of agencies mapped in the SLS, number of child agencies using SNA and number of Child agencies using Zero Balance Account. If the agency accounts are inactive, then it will not be shown in SNA03 report. On drill down, it shows the name and unique code of child agencies.
- 4. **SNA04 Interest Income** This report shows the quarterly Interest credited in the Single Nodal Account along with credit date.
- 5. SNA04A Interest Deposited Report shows the Total interest accrued in SNA account and deposited to consolidated fund of India. The total interest accrued includes the interest credited in current financial year and balance Central share interest of previous financial year which is yet to be deposited.
- SNA05 Central and state share Deficit This report shows central and state share deficit separately.
- 7. SNA06 Center and State Release details This report helps to get information about the delay in transfer of Centre share and State share. The data in this report is shown after the date of SNA marking. It shows only the treasury releases to SNA only.

- 8. SNA08 Head of Account mapping This report shows the central and state head of account mapping done with the State linked scheme. It helps the state user for reconciliation. If state has some issue regarding data the state user for reconciliation. If state has some issue regarding data shared but not appearing in SNA09 report, they can verify the head of account mapping of corresponding vouchers.
- 9. SNA09 Excess/Deficit in treasury transfer to SNA This report is used to calculate the excess and deficit in treasury transfer to SNA. It shows the Government of India Releases to State Treasury, Implementing Agency the Government of India Releases to State Treasury, Implementing Agency and ESCROW Account separately. The excess/Deficit is calculated on the basis of total release made from GOI (pre and post SNA marking), basis of total release made from GOI (pre and post SNA marking), corresponding proportionate state share (Which is calculated on the average sharing ratio) and the total releases by the state treasury (both SNA and non-SNA releases).
- 10.**SNA10 Voucher wise Treasury Release -** It shows the voucher wise data shared by the State treasury with PFMS through Treasury Integration. This report can be used by State finance department for data reconciliation. It gives the voucher wise breakup of the 'Release from State Treasury' column of SNA09 report.
- 11.SNA11 Excess/Deficit in State Treasury Transfer to SNA factoring
 30 days criteria This report shows the progressive actual deficit in treasury transfer to SNA. While calculating the actual Deficit, GOI releases of last 30 days are subtracted.
- 12.SNA12 Bank Statement of SNA It shows the bank statement of SNA account. It will help the SNA agencies to reconcile their expenditures and receipts.

B) CNA Reports

- CNA01 Comprehensive Report for Release and Expenditure This
 report is applicable only for the Schemes which are marked as CNA under
 Model 2. It shows the budget allocation for the scheme, GOI release and
 CNA release and expenditure details along with the bank balance of CNA
 account. Bank Balance is shown as shared by the banks with PFMS.
- CNA02 Agency wise allocation and expenditure This report is applicable for central sector schemes marked as CNA under Model 2. This report shows the agency wise limit allocation, Expenditure and advance. This report is based on the allocation data; so, it will show only those agencies which have been allocated limits by its parent agency.
- 3. CNAO3 Status of Agency Registration. It shows the CNA marked schemes, their marking date and Model adopted by them. No. of agencies mapped in the scheme and name of CNAs are shown only for CNA Model 2. The exempted Central Sector Schemes are also shown in the report with remarks as 'Exempted'.
- 4. CNA04 Interest Earned in CNA and Deposited in CFI This report is available for Central Sector Scheme marked as CNA under Model 2. Report shows the Total interest credited in CNA account and deposited to Consolidated Fund of India. The total interest credited drill down shows the quarter wise interest credited.
- CNA05 Bank Statement of CNA It shows the bank statement of CNA account. It will help the CNA agencies to reconcile their expenditures and receipts.

C) Report common for Both SNA and CNA

 EATO3 – Reloaded Component wise Summary – This report shows the component wise expenditure made in a Scheme. This report is applicable for all the schemes whether SNA/ CNA/ Exempted.
