- 03. The Pr. Secretary (Finance) apprised the Expenditure Finance Committee of the agenda items. Thereafter, H&FW Department presented its proposal before the Committee.

Health & Family Welfare Department

I. Expansion & Re-modelling of Dr. Hedgevar Arogya Sansthan at Karkardooma

(i) Pr. Secretary, Health & Family Welfare department has stated that the instant proposal is for increasing the number of beds from the existing 200 to 550 by expanding the existing hospital through pre-engineered building model and remodelling the existing structures. The work will be executed by PWD.

(ii) ADG, PWD has stated that the estimates are based on DPAR 2012 + 15% cost index minus 9% for scheduled items market rates for non-scheduled items with 1% each for contingencies, quality assurance, art work, labour cess and provision for furniture. Statutory clearances from DUAC & Fire Department have been obtained. EDMC have given special powers to PWD for approval of drawings by the Sr. Architect, PWD. Details of the proposal are as under:

- (iii) It was observed by the Finance Department that instruction was issued by the Office of Engineer-in-Chief, PWD dated 5.7.2019 that all construction work of PWD costing ₹100.00 crore or above shall henceforth to be executed on Engineering, Procurement and Construction (EPC) mode and enquired whether the instant project is being executed on the EPC) Model. It was informed by the S.E., PWD that the project could not be considered for execution under Engineering, Procurement and Construction (EPC) Model since the Consultant already prepared the detailed drawings required for construction and it will not be possible to call tenders on EPC mode now. Therefore, in order to avoid the duplicity of work entailing extra expenditure, the normal mode of contract is found suitable for the instant project.
- (iv) The Hon'ble Minister (Health) further observed that the project was conceived 3-4 years back and considerable time and money have been spent in planning and execution of the project. Therefore, in the public interest and to avoid wastage of money, PWD was directed to proceed as per normal mode. It was assured by ADG, PWD that all future/ new projects of PWD costing ₹100.00 crore or above shall henceforth to be executed on Engineering, Procurement and Construction (EPC) model only.
- 04. After due deliberations, considering the recommendation of Administrative Department on the requirement and its satisfaction regarding technical, administrative, operative, maintenance and financial aspects etc. Expenditure Finance Committee approved and sanctioned the proposal submitted by H&FW Department for expansion & re-modelling of Dr. Hedgevar Arogya Sansthan at Karkardooma at an estimated cost of ₹210.24 crore. This is subject to the following

- i. Project shall be completed as per approved scope of work at the sanctioned cost. No cost escalation will be considered in future.
- ii. The tender shall be invited as per the approved cost considered on the recommendation of the department.
- iii. Compliance of pre-sanction / post-sanction guidelines / requirement circulated as Annexure to Government order no. PA/DSF/Misc/2012-13/Exp-4/538-45 dated 17.05.2012 during planning and execution period.

II. Construction of New Hospital at Siraspur (Phase-I)

- (i) Pr. Secretary, Health & Family Welfare department has submitted that the proposal is for construction of new hospital at Siraspur. The Hospital is planned in two (02) phases and the instant estimate is for construction of Phase-I. The areas adjoining the proposed hospital are densely populated and there is no Government hospital in the nearby locality. The work will be executed by PWD.
- (ii) ADG, PWD has stated that the estimates are based on DPAR 2012 with 18% cost index minus 9% for Civil works, DSR 2016 +15.69% cost index minus 9.5%, and market rates for non-scheduled items with 1% each for contingency, labour cess, third (3rd) party quality control and Art work, 4.25% for ESI & EPF and consultancy fee @ 210/sqm. Being a new hospital, the project is proposed to be executed on Engineering, Procurement and Construction (EPC) Model.

(iii) Details of the proposal submitted are as under:

(iii) Engineer-in-Chief, PWD apprised the Committee that EPC agreements were composite contracts, under which, the contractors are required to conduct detailed survey and investigation, design the project and execute the works on turnkey basis. The contractors are required to quote a fixed lumpsum price at the time of tendering. Under this Model, all clearances will be obtained by the agency selected for the purpose.

- (iv) It was observed by the Pr. Secretary (Finance) that from the submission made by the Department it is ascertained that the concept plan/DPR for the entire project has been prepared by the Consultant and at present only Phase-I of the project is being executed. He further enquired whether the concept plan already prepared for Phase-II will be utilised, what is the tentative schedule for Phase-II and whether Phase-I and Phase-II will be amalgamated? It was informed by the Health Department that the Concept plan finalised only for Phase-I and planning for Phase-II will be taken up only after assessing the utility of Phase-I, resources availability, future requirement etc and as such there is no immediate plan to commence Phase-II. It was assured by the Engineer (PWD) that construction of Phase-I will be done in such a manner to accommodate any future expansion.
- 05. After due deliberations, considering the recommendation of Administrative Department on the requirement and its satisfaction regarding technical, administrative, operative, maintenance and financial aspects etc. Expenditure Finance Committee approved and sanctioned the proposal submitted by H&FW Department for construction of new hospital at Siraspur at an estimated cost of ₹487.54 crore. This is subject to the following
 - i. Project shall be completed as per approved scope of work at the sanctioned cost. No cost escalation will be considered in future.
 - ii. The tender shall be invited as per the approved cost considered on the recommendation of the department.
 - iii. Compliance of pre-sanction / post-sanction guidelines / requirement circulated as Annexure to Government order no. PA/DSF/Misc/2012-13/Exp-4/538-45 dated 17.05.2012 during planning and execution period.
