03. Pr. Secretary (Finance) apprised the Expenditure Finance Committee about the agenda items and thereafter, department concerned appraised about their proposals before the Committee;

#### I. Directorate of Education

# A. Construction of new building in the existing premises of Government Girls Sr.Secondary School, Shahbad Dairy

- i. Secretary (Education) apprised the Expenditure Finance Committee that two schools running at the existing double storeyed premises of Shahbad Dairy has been declared dangerous and unsafe and as a result of which the students have been shifted to another school at Prehladpur village. Therefore, a new four (04) storeyed /(G+3) SPS structure at an estimated cost of ₹32.44 crore based on DPAR 2012 minus 12% including 1% each for contingencies, quality assurance and labour cess, 6% service tax and furniture has been submitted by PWD.

04. Since the students of existing Shahbad Dairy school have been adjusted in the nearby schools and facing hardships due to increase in the strength of students, Chairman of the Committee directed PWD to expedite and execute the project at the shortest possible time and also ensure that the project is completed by June, 2018 positively.

- 05. After considering the recommendation of Administrative Department on the requirement and its satisfaction with respect to technical, administrative, operative, maintenance and financial aspects etc, the Expenditure Finance Committee approved and sanctioned the proposal of the department for construction of four (04) storeyed SPS structure in the existing premises of Government Girls Senior Secondary School at Shahbad Dairy. This is subject to the following:
  - i. Project shall be completed as per approved scope of work within 09 months at the sanctioned cost of ₹32.44 crore. No cost escalation will be considered in future.
  - ii. NIT shall be invited as per the approved scope of work and sanctioned cost.
  - iii. Compliance of pre-sanction / post-sanction guidelines / requirement circulated as Annexure to Government order no. PA/DSF/Misc/2012-13/Exp-4/538-45 dated 17.05.2012 during planning and execution period

### II. Directorate of Training & Technical Education

# A.Construction of Academic Block, Hospitality Block, & Hostel Block for World Class Skill Centre and Delhi Skill University at Village Jonapur

- i. Secretary (TTE) apprised the Committee that for construction of a World Class Skill Centre at Jonapur, Gram Sabha Land was allotted to the department in the year 2011 & 2013. The Ministry of MoUD has changed the land use in the year 2014 and accordingly a proposal to construct the first phase of the Skill Centre along with Workshop and Hostel for 5000 students was formulated. The project is a 'Green Field Skill Centre' with world class facilities being constructed for the first time in India.
- ii. The project was assigned to PWD which submitted a preliminary estimate for construction of Academic Block, Hospitality Block, Workshop, Substation & Hostel Block for World Class Skill Centre and Delhi Skill University at Village Jonapur at an estimated cost of ₹254.04 crore based on DPAR 2012/DSR 2014 minus 12% for scheduled items and market rates for non-scheduled items with 1% each for contingency, labour cess, third (3<sup>rd</sup>) party quality control and 6.2% Service tax.

- O6. During deliberations it was observed by the Committee that the project period of 33 months appears to be very long and asked PWD to curtail the schedule to the maximum possible extent. After re-assessing the time schedule as per PERT Chart it was agreed that the Project will be completed within 24 months. The Administrative department has been directed to strictly monitor the progress of the work through the 'Project Monitoring Committee' and PWD has been asked to adhere the committed time lines. PWD may begin the tender process in anticipation of Cabinet approval. However, work will not be awarded till the Cabinet approval is conveyed.
- 07. After considering recommendation of Administrative Department on the requirement and its satisfaction with respect to technical, administrative, operative, maintenance and financial aspects etc, the Expenditure Finance Committee has made the following recommendation, on the proposal for construction of Academic Block, Hospitality Block, Workshop, Substation & Hostel Block for World Class Skill Centre and Delhi Skill University at Village Jonapur at an estimated cost of ₹254.04 crore—subject to the following;
  - a. The proposal shall be placed before the Cabinet for approval and sanction alongwith all Statutory Clearances.
  - b. Project shall be completed as per approved scope of work within scheduled period at the sanctioned cost. No cost escalation will be considered in future.
  - c. Compliance of pre-sanction / post-sanction guidelines / requirement circulated as Annexure to Government order no. PA/DSF/Misc/2012-13/Exp-4/538-45 dated 17.05.2012 during planning and execution period

### III. Environment and Forests Department

- A. Extension of project period for rehabilitation of degraded forest land in the Southern Ridge area of Asola Bhatti, Dera mandi, Maidangarhi, Ghittorni and Rajokri through Eco Task Force from 1.4.2017 to 1.3.2022i
- i. Addl. PCCF, Forest Department submitted the proposal for continuance of 132 Eco Task Force (Territorial Army) for further period of five (05) years from 1.4.2017 to 3.3.2022 for improving and sustaining the wildlife habitat through plantation of native and fruit bearing species to the resident wildlife and monkeys trans located in Asola/Bhatti and Dera Mandi areas at an estimated cost of ₹98.47 crore. The estimated cost has following components;
