

- (i) The Pr. Secretary, Education apprised the Expenditure Finance Committee that there is acute shortage of classrooms in existing schools. Therefore, requisition was placed to PWD for construction of additional class rooms. To ascertain the feasibility for construction of additional rooms and available vacant space in each school, a survey was conducted by PWD in all the Government Schools. Accordingly 241 schools were identified in 12 Zones in which 12748 class rooms are proposed to be constructed.
- (ii) On the basis of survey, PWD has prepared a preliminary estimate of ₹2892.65 crore based on DPAR 2012 minus 12% including 1% each for contingencies, quality assurance and labour cess, 6% service tax and provision for furniture. Details of cost components included in the estimate are as under;

But the instant proposal is not only for construction of additional class rooms but also for overall improvement of infrastructure in a school. Due to shortage of water, provisions such as Rain Water Harvesting, STP, UG tank were taken up along with some up-gradation/improvement of allied infrastructure in a school.



II. Construction of a new Hospital at Burari (Revision)

(i) It was submitted by the H&FW department that the original proposal for establishment of 200 bed hospital at Burari was approved by the Cabinet at a cost of ₹182.77 crore vide Cabinet decision No. 1926 dated 27.8.2012. The project was started on February 2013. 65% of the entire work and 85% of the hospital structure has been completed. Meantime, to accommodate more number of beds the project was reviewed and it was ascertained that by undertaking some structural adjustment the bed capacity can be enhanced adequately. Accordingly, additional covered area have been carved out by adding one additional floor and by covering open space at other floors. Details of revised proposal are as under;
